- Monday, September 30-Full Day Program offered at Fidelity House. Sign-ups available on the website beginning on Wednesday, 8/21/19.

- Bishop - We meet inside the front door.
- Brackett School—K in K Hallway. Gr 1-5 We meet inside the cafeteria.
- Dallin-We meet inside the front door.
- Hardy—We will meet inside the front door.
- Peirce—We will meet inside the front door.
- Stratton—We will meet inside the front door.
- St. Agnes -- We will meet children in the auditorium for walk-over.
- Thompson-We meet inside the front door.

All students must come directly to the pick-up point, at the first bell to meet the Fidelity House Van. If for any reason, a student cannot be at the pick-up point on time, you must notify Fidelity House by telephone before 1:00 PM that your child will not be using transportation.

Please inform your child's classroom teacher, that your child will be picked-up by Fidelity House. Some schools allow the children to go out a different door, at an earlier bell for their safety and convenience. This also ensures that the child will not be kept after school for any reason, as we are not able to wait for children who are staying after school.

CALL US IF YOUR CHILD IS NOT GOING TO ATTEND- On any day when your child will not be attending the after school program, please call us between 8:00 a.m. and 1:00 p.m. so that the staff picking up the children will know not to look for your child. It is difficult for us to get messages from the school office. Even if you are picking up in person at the school it is important to let us know ahead of time. **In any case where we have not received permission from you not to pick up the child that day, we will require the child to come to Fidelity House.**

Open Recreation

The tentative date for Fidelity House's Open Membership recreation programs is Tuesday, September 24th. Fidelity House's Open Recreation Program is available for children in Grades 6 & up.

After-school programs at schools (ie: band, drama, Girl Scouts, etc) If your child is participating at programs at their school and arriving at Fidelity House late, **please notify us in writing.** We need to know the program they are attending, the dates, and the time they will arrive at Fidelity House. We are not able to transport children to and from activities that occur after the regular dismissal time at your child's school.

Billing Notes-

- **Paperless bills and newsletters-**Beginning with the October bills, we will be sending all correspondence through email instead of paper. If you already have an on-line account, you are all set. **If you do not yet have an account, please set one up for future billing months at www.fidelityhouse.org** If you prefer a paper copy, please pick it up at the Front desk.
- Bills are posted on-line each month and payments are due the first week of the month (with the exception of the September Bill which is due, August 1)
- Extended Care will appear on the bill for the next month.
- If your child has an early release on one of their regular scheduled days, they are automatically billed for the extra time.
- Full days are not included in the bill, as you must sign up for these separately. Sign-ups are available on the website at the end of the month, for the next month.
- **Please give us 30 days notice, in writing, of any changes to your child's schedule, or you will be billed for that period. Change of Schedule forms are available in the office or on-line.**
